4. To furnish to the second Party, a consolidated report based on feedback received from college and students after the course/training.




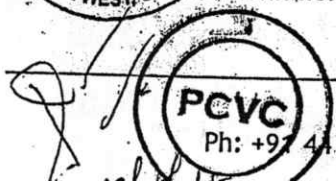
PCVC and MGC are desirous to enter into a Memorandum of Understanding between them, setting out the working arrangements that each of the partners agree are necessary to complete the Project.
